## Objective

The world has been through dramatic changes, in almost every aspect of the society: economy, politics, environment, employment and technology. Increasing population, economic growth, and the need to improve access to modern energy services for hundreds of millions of people will put additional pressure on energy resources and the environment.

Due to its qualities and availability natural gas can play an important role in helping energy policy makers to meet the energy and environmental challenges. Sustained energy policies and stable fiscal regimes contribute to reduce uncertainties in the investment climate and enable the industry to plan, invest and meet future energy needs. Improved cooperation within the industry and with other stakeholders, including governments, best catalyzes natural gas development and global energy security.

The IEF-IGU Ministerial Gas Forum is now established as a regular platform for Ministers and senior decision makers to discuss key developments in the gas industry. The 3<sup>rd</sup> IEF-IGU Ministerial Gas Forum will investigate how the complex and various challenges facing the gas industry can be facilitated by sustained energy policies, long-term partnership and enhanced cooperation.

Discussion points:

- How to improve the national and regional policies and regulatory frameworks so gas infrastructures and supplies are developed in line with future needs? How does new regulation and strengthened safety requirements impact costs?
- How to steer cooperation to facilitate and encourage technology development and deployment along the whole gas chain (production, transportation, storage, distribution and use)?
- Is the divergence between spot gas prices and oil-indexed prices a temporary phenomenon or a structural trend? How does the global variation in gas prices affect investment and trade? Does gas pricing need to be revisited in light of recent developments and structural changes?
- What are the key barriers to trans-regional gas pipelines' expansion? How can such barriers be overcome to enhance energy security for gas exporting, importing and transit countries?
- Could a new approach to energy cooperation reduce economic and political risk thus improving energy security both for producing and consuming countries?
