





### Focus of the Utilization Committee

The Utilization Committee will focus on issues related to the utilization of gas in residential, commercial, and industrial markets, and the use of natural gas as a land and marine transportation fuel.







# The Committee will organize three study groups on the following topics:

#### **Industrial Utilization**

- Analyze trends in gas utilization in industrial sector
- Compare international experience on energy efficiency (technologies & regulation)
- Explore combination of natural gas and renewable
- Study 'gas to power' technologies & techniques
- Investigate the role of energy services in industry

## Domestic and Commercial Utilization

- Monitor the results of the market introduction of gas heat pumps and micro-CHP
- Investigate gas appliances with condensing and modulating properties in combination with other appliances like the electric heat pump (hybrid systems)
- Monitor adsorption heat pump will be monitored Study "smart" features of micro-CHP
- Check and investigate business models regarding new technologies and associated services

#### **Natural Gas Vehicles**

- Monitor world NGV market and propose Action plan for NGV/CNG in Europe (5% of market in 2020/2025)
- Examine CNG/LNG/BioM technologies, economics, local policies & incentives
- •Study LNG potential for ground, air, water, rail, etc...
- •Observe 'NG +' concept: NG + H2, BioM , Diesel, e-power Hybrid CNG
- Promote synergy between OEM and retrofit vehicles
- •Spread real life experience: success and failure stories from fleet operators, drivers, local authorities, etc.

#### Renewables, CO2 Emission, Hydrogen

- -Gather information about global production and use of "green gases" in combination with natural gas.
- -Monitor global technology, sources, efficiency, costs for production of hydrogen/methane from renewable power; electrolyzing technologies (ALE, PEM and SOEC); technologies to convert CO2 + H20 to CH4.
- -Prepare global overview of ongoing projects for integration of renewable gas into the local natural gas grid – inclusive a status for upgrading technologies

### **Focus of Strategy Committee**



  percent of world gas consumption.






Figure 3.1: LNG Trade Volumes, 1990-2013 Source: IHS, IEA, IGU

## Focus of the Research and Development and Innovation Committee

The Research and Development and Innovation Committee will support the 2017 International Gas Research Conference by encouraging input from R&D institutes and researchers and creating and executing the conference program.

The Research and Development Committee will also work closely with the Marketing Committee to advance the higher acceptance of gas through the promotion of technical innovation.

The Committee will promote exchange and collaboration in global natural gas research, technology transfer, and emerging technology and innovation that is occurring across the entire natural gas value chain.
