**Subject:** RE: IGU PGC D.4 Meeting,Osaka

To: Members of IGU PGC D.4 Study Group, “Life Cycle Assessment of LNG”

At the Osaka meeting this week, the following detailed outline was developed and initial writing assignments for outline sections were volunteered and assigned. Sections receiving active attention for development are shown in **red**; the other sections will require LCA data development (discussed further below). The base document for these written sections will be maintained under “Study Group Report” on the IGU website collaboration pages for our Study Group. The first version of the base document (incomplete) should be posted by 30 May 2014. The base document will be in Microsoft Word format. Study Group members should regularly review the base document and add and modify text using the “Review” features of Word, including strike-throughs for proposed text deletions and underscored text for new text. In doing so, Study Group members should also provide a comment justifying his/her proposed revisions using Word’s “Comment” functionality.

You will notice that the detailed outline emphasizes natural gas advocacy in Background and Introduction sections. This focus is in keeping with IGU’s increased efforts on natural gas advocacy generally. The participants in the Osaka meeting do not believe that this emphasis will diminish the technical quality, utility, or justification of the Study Group report. It will improve the readability of the report in delivering IGU’s advocacy message and should substantially reduce the dryness of the technical discussion of LCA emission factors, which will be the principal technical contribution of the Study Group report.

As you can see from the attached detailed outline, volunteers for these initial writing assignments represent a very narrow slice of the PGC D.4 Study Group membership. Other Study Group members are expected to step up to volunteer for other report development activities from now until the completion of the report development through January 2015. Additionally, Study Group members are expected to participate in conference calls, which will now be regularly scheduled on a monthly basis.

In addition, assignments for development of graphical images (diagrams, photos, schematics) have been delegated to Sharifi and Olga. Development of a data template for spreadsheet archiving of data and simple LCA modeling has been delegated to Jukka and Max (Max, I will follow up with you separately).

As an update of prior information, we have received assurances that funding of contractor support for data development will be forthcoming. Details on this arrangement need to be worked out before I can share them with you. We have reached a critical milestone where development of the module-based, emission factor-driven analysis can only proceed with this additional support. If for some reason this support does not materialize, a substantially-altered work effort will have to be implemented. I am confident that this will not become an issue, however.

Please look for upcoming notices of conference calls (which will be shown on the IGU website calendar as well as in direct email notices) and posting of the base document.

**Subject:** IGU PGC D.4 Meeting,Osaka

To: Members of IGU Study Group PGC D.4

In preparing for next week's meeting in Osaka, you should be aware of the following:

- The Center for LNG (U.S.) is having a Board of Directors meeting today to consider the recommendation of its Technical Committee to fund data analysis for our life cycle assessment (LCA) data gathering activity. The meeting is in Houston, Texas, and I cannot attend. I requested to receive news of the Board's decision, so that I can announce it at next week's meeting of our Study Group. I have responded to a number of good questions concerning our request that lead me to believe that we will receive a favorable answer to our request. However, that is only an impression I received. I will pass along information on this to Study Group members who cannot attend the Osaka meeting as soon as information becomes available.
- According to the PGC D leadership, the focus of the Osaka meeting is to be on development of study group reports. In response to that emphasis, I have highlighted sections of the report outline developed in Barcelona (which includes some minor changes) that expect to begin working on in Osaka. The following is that highlighted outline (areas to be addressed shown in red):
  - Executive Summary (not to be addressed until report is completed)
  - Introduction
    - Background
    - Purpose and Scope of the Study
    - Overview Discussion of LNG Chains
  - Technical Approach
    - Use of Chain Modules and Assumptions
    - System Boundaries
    - Data Quality Characterizations
    - Examples of Chain Descriptions and Study Applications
  - Modules (not fully addressed until data development proceeds)
    - Liquefaction (including feed gas to plant boundary)
    - LNG Transport (marine carrier and overland transport)
    - Regasification and LNG End User Delivery (e.g. bunkering, vehicle refueling)
  - Case Study Illustrations (to await data development, for the most part)
    - Three to 4 case studies

- General Recommendations for Report Use (Initial text based on Study Group expertise)
- Potential Technology Roadmapping Applications (Initial text based on Study Group expertise)
- Study Conclusions (to await completion of the work referred to above)
  - Potential mitigation opportunities and “hot spots,” operational changes, process efficiencies, power sources and their emissions streams, CO2 management)
- Recommendations for Future LCA Studies (to await completion of the work referred to above, for the most part; initial text based on Study Group expertise)
- Appendices (to await completion of the work referred to above)
  - Data sets
  - Others to be decided.

Since data has not been compiled for the demonstration of LCAs and other data-related topics can be address in written sections at this time, all major sections where discussion or use of data would be required will not be addressed at the Osaka meeting, Instead, qualitative discussion topics are emphasized in the outline above.

Writing will proceed with development of high-level “topic sentence” development building on the outline to help ensure that logical flow of the document will follow. The principal activity at the Osaka meeting will be formulation of complete, well supported topic sentence statements and supporting subtopic statements. Major topic sentences will be followed by multiple levels of supporting subtopic statements to fill out the narrative. Where more information or Study Group consensus is needed to support a topic statement, that topic statement will be highlighted for further study beyond the Osaka meeting. In final form, the topic sentence structure can be used and reviewed by all Study Group members for agreement or further discussion, most immediately within conference calls on the project. Since we have gone away from the task group approach (as of the Barcelona meeting) and have essentially a smaller group and narrower scope, the topic sentence approach to writing a report is a very practical means for formulating group consensus while putting together a logically organized report.

- I am assuming that Study Group members will have collected various source of information on LCA studies related to LNG generally or have developed the facility to review information that we have posted on the Study Group websites (starting with the AGA SharePoint website and now transferred to the IGU website). Beyond the “brainstorming” of topic sentences during the meeting sessions, I expect that a significant amount of time will need to be devoted to reviewing information sources on hand from these documents and researching other information sources. Study Group members should come to the meeting with a mindset to “mine the information” available and conduct some web-based research to look for additional information. Also, if you have other sources of valuable information on hand but not on the IGU website, please bring it to the meeting, preferably in electronic form.

I propose that these activities go forward at the Osaka meeting, regardless of the outcome of the Center for LNG decision on providing financial support for data collection. However, if the decision is unfavorable to hiring a support contractor (that is, if Center for LNG decides not to provide funding this calendar year), we will have to devote some discussion to alternative means of compiling LCA data.

In any case,, I might ask you to review some of the background information on the Study Group activities and consider which of the three Working Groups you would like to be a member. Among the choices are: Liquefaction, LNG Transport, and Regasification. Materials on the website discuss in detail the decisions to date on Working Group scopes and activities. Again, welcome.
