






Looking back (2009 and 2012)





Goal 2050 Natural Gas Perspective 2012-2015



Key developments that will shape 2050

Each of us to:

- Identify three potential key developments that could shape the 2050 gas market



 - Stringent energy conservation: Europe and CIS





Getting there... (information collection)
