


Sectors of activities:

Our Mission

Mission:

- ✓ To conduct studies on technical and scientific problems;
- ✓ To produce the Technical Standards;
- ✓ To support Authorities, Institutions, Gas Sector Operators and other Stakeholders

Context:

- ✓ Fuelling gases transported / distributed: production, processing, storage, transportation, distribution and metering;
- ✓ Odorisation of natural gas and LPG in tanks;
- ✓ Safety, Installation and performances of plants and appliances for gas distribution and utilization and related metering systems, regulators, control and safety systems;
- ✓ Gas Transportation, distribution and utilization for domestic and industrial uses.

CIG Institutional Activities - 1

Production of Technical Specifications (on UNI's proxy)

- *Proxy renewed in 2008 no deadlines;*
- *Single entity with proxy for the gas sector;*
- Single entity with proxy for representing UNI at CEN and ISO level for the gas sector.

Support to AEEG (MoU between CIG e AEEG)

- MoU signed in January 2008, renewed in 2010 and 2014.
- Three years validity, renewable.
- *Targets clearly defined.*
- Possibility of economic contributions.

Insurance in favor of the Domestic Final Users of gas against accidents (by AEEG mandate)

- *Mandate renewed by AEEG in 2013 for the 5° time.*
- 5° contract signed in November 2013, covering the 2014-2016 period.
- Very strict obligations for CIG and Insurance Company.
- Funding: up to 1 euro per year per each of the 21,6 million points of domestic gas delivery.

CIG Institutional Activities - 2

National Statistics on gas accidents and in gas emergencies and related activities

- Ex AEEG Deliberation 168/04 and Distribution Guidelines.
- Statistic in production since 1988.
- MoU with VVFF Ministry of the Interior Firefighters .
- CIG in ETPS since 2004.
- CIG Obligations: to provide information and education on safety.
- Forum UNI-CIG on gas safety.

Activities for safety and prevention

- Law 1083/71, D.M. 37/08
- Deliberation AEEG 40/04 and 574/13 (new coming soon)
- Obligation to produce Technical Standards and Guidelines.

Other supporting activities

- Limited to the institutional obligations
- Publicity and education on safety

- In cooperation with our Stakeholders.





CIG – Governance




CIG – Committee for Technical Coordination - CTC

TCs duties and its rules

- Executing the TC working program
- Decision to endorse standard drafts prepared by individual WG and must send it to the Secretariat of CTC for the following procedural steps;
- To propose to the President of the CTC, for the necessary ratification, the establishment and disbandment of WGs and / or deal with the study of specific topics.
- Proposes the participation of technical experts not belonging to any sector but useful to the purpose of the TC works.
- The meetings of the TC shall be convened by the Secretary of the CTC on behalf of the Chairman of the TC
- The TC meetings must be convened at least twice a year, to make the final of the previous six months and prepare the work program for the following year.

The CTC proposes to UNI:

- •The adoption of ISO standards as national standards (ISO);
- •The national implementation of CEN standards and the simultaneous removal of any UNI standards overlapping;
- •The withdrawal of UNI and UNI ISO standards obsolescent;
- •The withdrawal of the technical specifications UNI / TS or their transformation into UNI standards.
